Councilwoman Martz stated her reports were in the dropbox. The code report was 11 complaints in November and 9 were property maintenance and junk vehicles. 1 court complaint agreed to clean up their vard. There is only one apartment complex to complete.

The Mayor stated county will do zoning map for free with the planning board.

Councilman Krause thanked for the tree lighting ceremony help, and this weekend with the breakfast and luncheon and the lighted parade on Sunday.

Councilman Saxton stated the roof leaks are fixed for now but may need new roof. The basement sump pump is fixed.

The Engineer stated the NJDOT 2017 aid applications are due Feb 3.

The Solicitor stated he reviewed the ALVI bond and all was in order. And he is working with the Police Chief on an OPRA request.

The Council agreed to cancel the December work meeting until December 27 at 10:00 am.
