Councilman Whalen confirmed the temporary budget is still in place and the employee evaluations should be completed.

Councilwoman Bonamassa stated trash and recycling tonnage has been light. Tree branches are being chipped, and patching pot holes. The new toilets have been installed in the upper bathrooms at borough hall. The negotiations have begun for the DPW union members.

Councilwoman Martz stated her reports were in the drop box and she has submitted a new grading ordinance for review and future action. She stated the reexam from the County was not understood by the planning board so the Borough Clerk will attend the next meeting to help explain. The apartment inspections are completed.

Councilman Krause stated he had a meeting with Dr. Pross from the Magnolia Public School related to Youth Day planning. He attended a Sterling High School Strategic Planning meeting which there will be future meetings to continue the process. The renovation planning related to the recent County Open Space grant will begin for Albertson Park. The Historic Society is planning a show in early May where residents can come review items salvaged from St. Greg's and the opening of the time capsule.

Councilman Saxton stated the drain at the entrance to the basement has been fixed. The cameras at the Borough Hall have been upgraded. The National Night Out Committee will begin planning with Lawnside3-Plans are to upgrade the entry system at the Rec Center. Open Gym Night has started on Thrusdays from 6:30 to 8:30 pm. There will be more chairs ordered for the Rec Center by June.

The Engineer stated the NJDOT project for 100 and 200 block of West Brooke will be out. The AAA Hobbies sidewalk has been completed. The light survey for Columbos Liquor has been completed and letter will be going out for non-compliance.

The Solicitor stated the chicken and housing ordinances will be completed at the next meeting with a public hearing and final action.

Richard Michielli stated the refund for the County JIF is ready to be issued.
