Public Safety & Compliance Councilman DePrince gave the police activity report and stated that the order has been placed for a new police car following the recent accident and the financials will work out.

Finance & Administration- Councilman Whalen discussed the Audit Correction Plan, the Lincoln/Madison Bid, speed humps, DPW remediation, the Clerk position and front office set up.

Public Works & Technology- Councilwoman Bonamassa reported that the trash was unusually heavy and there was nothing new to report on contraction negotiations. The junior field is in good shape, but raised questions with respect to the field usage without the proper procedures being followed. Councilman Saxton stated he would look into it.

Planning/Zoning, Codes, Licensing & Street Lighting- Councilwoman Martz gave the Code Report Summary and stated that there was nothing on the June Planning Board Agenda. Councilwoman Martz also gave updates on the Community Champions program.

Facilities & Community Development- Councilman Saxton reported that the fob system was installed at the rec center and the key locks will be changed by next week.

Mayor- Mayor Cowling-Carson updated Council on Sterling High School graduation, the Magnolia School Yearbook, proposed banquet halls, Wild Wings Café in Barrington, Chick Fil A, Miss Laurel Springs, Miss Bellmawr, Little Miss Magnolia, the 8th grade Promenade, Cross-Camden County Trail, Sterling's Awards, Fire Graduation, NJDOT Project, Farmer's Insurance Ribbon Cutting, Magnolia Public School Graduation, Pasadena Drive Construction, Gas Company work, NJDEP Clean Communities, Brooke Avenue Project, SJ Gas, Swift 911, Magnolia Medal and Volunteer of the Year, and a Korean War POW with a relative from Magnolia was recently identified and will be given a proper burial this coming weekend. The Mayor reminded Council that the next meeting was next Thursday and that all agenda items needed to be submitted in advance.

Councilman Krause arrived at 7:45 p.m.

Public Events- Councilman Krause thanked Council for its help with Memorial Day and reported that the focus has now turned to July 3rd and 4th. Councilman Krause also gave updates on National Night Out and the park.

Solicitor- Mr. Long discussed the Lincoln Avenue bid and that he had one personnel item for Executive Session.
