OLD BUSINESS

Re-Examination of the Master Plan:

Mr. Levecchia addressed the board regarding some of the comments that he had been presented with via email. The plan was written as a sample, anything pertaining to Somerdale has been corrected. Mr. Brown questioned about Brownfields, if it is perceived or has hazardous conditions.

There was discussion of Route 30 & Davis Rd, the old boat store, White Horse Pike & Ashland Ave, widening of the properties. Mr. Barrar feels it may be a good idea to make a connection there. Mr. Moore mentioned wetlands, and a possible stream that ran through North on White Horse Pike. Mr. Levechhia mentioned and environmental resource inventory based on the topography. The question arose if there are resources that benefit the town. Mr. Levechhia commented that the original Master Plan dates back to 1978. The County will assist, and can be a part of writing a new Master Plan, but they do not write it. A re-examination report is a professional commentary of an existing report. There are 5 questions to be answered from Municipal Land Use Law. 2009 was the last re-examination. There are Community Development Block Grants various grant programs to assist with funding for the writing of the Master Plan. On the Map, pointing East of White Horse Pike there is an opportunity for trans-adjacent development. All zoning changes will need to go through Council for approval, and a new map will be prepared.

Mr. Levecchia will go over the report, make any necessary changes, and prepare for the next meeting scheduled December 20th. 2017.
