COMMITTEE REPORTS:



PUBLIC SAFETY & COMPLIANCE – Councilman DePrince

Councilman DePrince had nothing to report for the Court department, as everything is working out with the new Court Administrator. Councilman DePrince spoke of the recent meeting that was held at the Magnolia Public School, and the turnout that was present by school families. The school is following all safety protocols, and always looking to improve. The idea of placing a panic bar on the rear access gate of the school came up as a suggestion. Mayor Cowling-Carson wished to honor Emily Krause for holding a peaceful vigil at the school for the recent victims of the Parkland, TX school shooting.

FINANCE & ADMINISTRATION – Councilman Whalen

Councilman Whalen gave a friendly reminder that the temporary budget has been fully extended, and to be mindful of spending while the budget is complete. Councilman Whalen reminded everyone to complete the JIF course recently offered on Ethics, and to hand in the certificate to the Administrator when complete. Councilman Whalen also reminded all to complete the FDS, when it opens for filing.

PUBLIC WORKS & TECHNOLOGY – Councilwoman Bonamassa

Councilwoman Bonamassa stated trash and recycling collection was normal this month, but that 3 tons of road patch was put down throughout town. A suggestion came up to use Runnemedede's sewer pipe camera to see where the recent sewage spill came from to assist in remediation. Approximately two thousand three hundred dollars (\$2,300) has been put aside for street sign repair. Councilwoman Bonamassa mentioned that the Administrator is holding conversations with phone vendors on a possible new system which will provide a more cost effective way of phone service.

PLANNING/ZONING, CODES, LICENSING & STREET LIGHTING – Councilwoman Martz

Councilwoman Martz stated that due to a recent Uniform Construction Code (UCC) change, roofing and siding permits are no longer needed for certain replacement projects. Councilwoman Martz mentioned a meeting was held with the business owners of the buildings located at 801-811 W. Evesham.

PUBLIC EVENTS – Councilman Krause

Councilman Krause made mention that the dates have changed for cLean Communities Day and the Easter Egg Hunt. Clean Communities Day will now be held on March 24, and the Easter Egg Hunt will be held on March 31. There will be a Recreation Committee meeting this Sunday, and they will be stuffing the 1,500 Easter Eggs with prizes. All are welcome to help and donate their time to assist. Youth in Government Day planning is continuing with some new developments to include an essay writing contest, a visit to the American Legion Edwin I. Johnson Post 370, and learning how to properly fold a United States of America flag. A 1946 Jeep will be used in this year's parade to honor the Legions longest living veteran, Tom Gallagher, who is 95 years old. Magnolia Day planning continues, which will now feature the movie "Invincible" to be played at the Community Center field, with hopes for an appearance by local athlete Vincent Pappale.

FACILITIES & COMMUNITY DEVELOPMENT – Councilman Saxton

Councilman Saxton reported that there was a leak in the courtroom due to a sewage backup. The line was snaked with a camera to determine the location of the blockage, and it is believed to be under the restrooms by the Police station. We are looking into borrowing a camera from a local Borough to snake the line ourselves to determine the exact location of the leakage before remediation takes place. The Borough Hall roof needs replacement, and quotes have been received that exceed the bid threshold, and this project will need to go out for public bidding. Councilman Saxton will work with the Engineer on specifications. Several Field Usage Applications were turned in to the Administrator, and were submitted for discussion.

A motion was made by Councilwoman Bonamassa and seconded by Councilman Krause to close public participation. All Council who were present voted aye.

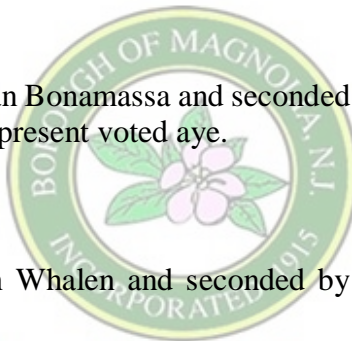
ADJOURNMENT:
