

**MINUTES**  
**COUNCIL MEETING**  
**NOVEMBER 06, 2013**  
**7:00 p.m.**

In compliance with N.J.S.A. 10:4, Open Public Meetings Law, notice was given to two newspapers and posted, that a council meeting of the Mayor and Council was scheduled for Wednesday, November 06, 2013 at 7:00 P.M. The Municipal Clerk took the roll call and showed that all were present. The Engineer Mr. Basehore and the Solicitor Jack Kennedy were also present.

The Mayor asked for to go into Executive Session. A motion to adopt Resolution 2013:161 was made by Councilwoman Martz, seconded by Councilwoman Bonamassa with all Council voting aye. The reason was for Personnel.

A motion was made by Councilwoman Bonamassa, seconded by Councilman DePrince to come out of Executive Session with all Council voting aye.

Motion made by Councilman DePrince, seconded by Councilman Michielli to adopt the October 17, 2013 meeting minutes, with all Council voting aye.

Motion was made by Councilwoman Martz, seconded by Councilman Michielli to adopt Resolution 2013:162 for Maintenance Liens on one property of \$150. for 113 N. White Horse Pike, and all Council voted aye by roll call vote.

A motion was made by Councilman DePrince, seconded by Councilwomn Martz to adopt Resolution 2013:169 to appoint Dawn M. Neukirch as Court Recorder as recommended by the Court Administrator. All Council voted aye by roll call vote.

Motion was made by Councilman DePrince, seconded by Councilman Michielli to adopt Resolution 2013:170 to appoint SLEO II Michael Waters effective November 06, 2013. All Council voted aye by roll call vote. Michael Waters was sworn in.

Motion was made by Councilman Whalen, seconded by Councilman DePrince to adopt Resolution 2013:171 to cancel small balances for two properties for CCMUA tax sale issues for B. 5.02, L. 1 and B. 8.03, L. 7. All Council voted aye by roll call vote.

Councilman Whalen stated he submitted the Treasurer's Report in writing.

Committee Reports:

Councilman DePrince stated he and the Mayor attended a meeting to review the incident on Washington Avenue which was very informative and a good learning tool. A table top drill has been planned for December with a full scale one planned for the Spring of 2014.

Councilwoman Bonamassa stated Lt. Stetser was training the DPW on how to remove the sensitive information from old computers so the systems can be properly disposed of at the electronic collection in December. She expressed a resident's complaint with traffic at the intersection of Evesham and Lakewood and the possibility of a "X" box marking at the intersection to keep it clear and open. Councilman Whalen stated he would review and confirm funding for the engineer to complete the work which is the first step in the process since it is a county road.

Councilwoman Martz stated her reports were submitted, but reported the rabies clinic there were 48 dogs and 15 cats from Magnolia treated, and 4 dogs and 5 cats from out of town. She reported the old barber shop on Evesham Avenue was sold to a new barber. Also the Sanders property should be applying for permits soon.

Councilman Michielli thanked everyone involved in the Halloween parade and activities. The breakfast for the children in December and the senior luncheon was being planned. There was a recreation meeting planned.

Councilman Wilson reported the carpet installation went well. The issue of no natural gas service at the DPW facility was resolved.

The Engineer stated his report was submitted in the dropbox.

Motion was made by Councilman Michielli, seconded by Councilwoman Martz to open the meeting to the public, with all Council voting aye.

No one from the public spoke.

Motion was made by Councilman Michielli, seconded by Councilman Wilson to close the meeting to the public, with all Council voting aye.

Motion was made by Councilman Whalen, seconded by Councilman Michielli to pay the bills, with all Council voting aye by roll call vote.
