FEMA Mitigation Plan

Camden County is participating in updated their Multi-Jurisdictional Hazard Mitigation Plan which was approved by FEMA in 2010 and 2011. The update is being led by the County Office of Emergency Management with the assistance of Stuart Wallace, LLC, a mitigation planning consultant. The County is offering this consultant to the local municipalities including Magnolia. Hazard Mitigation Plans are required by FEMA (Federal Emergency Management Agency) to establish and maintain eligibility for federal hazard mitigation project grants that in turn can help communities implement measures to reduce risk. Plans must be updated on a five year cycle to maintain eligibility. At the conclusion the updated plans for the County and Magnolia will address issues that are most important to the residents, businesses and property owners. FIRE

In September the Fire Department attended the State Firemen's Convention. The department won several awards for their participation. Also this year the fire department received a new fire truck which was well needed to help better protect the residents of Magnolia.

Fire Prevention Open House will be held again this year at Magnolia Fire Station. Come out on Saturday morning, October 11th from 10:00am-1:00pm to see you firefighters and equipment. There will be displays and handouts for all. We look forward to seeing you there.

SMOKE ALARMS

- Almost three of five (60%) of reported home fire deaths in 2007 to 2011 resulted from fires in homes with no smoke alarms or no working smoke alarms.
- Working smoke alarms cut the risk of dying in reported home fires in half.
- In fires considered large enough to activate the smoke alarm, hardwired alarms operated 93% of the time, while battery powered alarms operated only 79% of the time.
- When smoke alarms fail to operate, it is usually because batteries are missing, disconnected, or dead.
- An ionization smoke alarm is generally more responsive to flaming fires and a photoelectric smoke alarm is generally more responsive to smoldering fires. For the best protection, or where extra time is needed, to awaken or assist others, both types of alarms, or combination ionization and photoelectric alarms are recommended.



Reminder: the Construction Office is open Monday eve. from 4:30 p.m. to 6:30 p.m.

Pitfalls to avoid when hiring a contractor

- . Ask to see the contractor's NJ State HIC license.
- DO NOT give the contractor a deposit for more than the value of the material.
- Make all payments by check, not cash regardless of any discounts the contractor may offer.
- If the material amount is sizeable, ask the contractor for a quote from the supplier. Issue a check in the exact amount of the quote directly to the supplier. An otherwise reputable contractor may not have the funds or credit to start you job but should be willing to break down the material / labor / profit and overhead split.
- Typical hourly rates are running between \$25.00 and \$100.00 per hour depending on the size of the contractor's company and whether or not he is doing the work himself. Overhead and profit should be in the area of 10% & 10% respectfully.
- DO NOT take the building permit out yourself, make the contractor do it. If he won't there is probably a reason so find another contractor.
- Last but not least, under NJ State Law, final payment is not due to the contractor until final inspections have been made by the Building Department and a certificate of approval has been issued.
- Borough Ordinance mandates every rental property be registered; forms available at Borough or on website.
 Property will then be inspected and then ready for lease.
- Any property not owner-occupied is considered a rental property and must be registered with Borough.
- Anyone found to be in violation of this Ordinance is subject to a fine up to \$1,000.

DOG AND CAT LICENSING

Remember there is an Ordinance prohibiting more than 2 dogs and 2 cats per household. Our free rabies clinic is Nov. 1st at the Ambulance Squad; 10am-

12pm, it is open to all residents of Camden County.

Vote by Mail is Now Available from the Office of the County Clerk

Vote by Mail has replaced Absentee Voting in the State of New Jersey. It allows a voter to vote without going to the polls on Election Day. You can apply by completing an application and sending it to the County Clerk. Your application must be received seven (7) days prior to the election. You can also apply in person to the County Clerk's Office up until 3:00 pm the day before the election. Stop by Borough Hall for an application now.
